## General

This year's theme for the course In-depth reflection is *Localities*. The topic introduces the 'local' as a place, as habitat, relationships and systems embracing situated practices in smaller scale but addressing global concerns.

It aims for a *dig where you stand[i]* criticality examining knowledge, narratives, interdependencies and materiality in a chosen specific context.

Individually and collectively participants test ideas using their previous experiences in tandem with an inquiry of both learning and unlearning engaging in matters of facts, speculation, concern and care.

Welcome. Let's move matter.

## Course structure and teaching methods

Students will formulate an inquiry of their own (or in collaboration with other students, external partners etc.) leading to a design proposal.

To open up for further practices and perspectives students from Interior Architecture (M2) will take part in the format of Peer Groups .The common theme of 'localities' will serve as an overarching framework engaging the two classes during a part of our 10-week course.

Within the Peer Groups examples of materials, techniques, form giving, methods and readings can be shared.

Beyond field trip, study visits, exercises and seminars various formats such as review and tutoring is regularly planned (see CANVAS schedule).

# Course Requirements

#### **Examination**

Examination is based on oral and visual/material presentations and the submission of documentation of the process and outcome as PDF.

## Grade Criteria

In order to meet the passing grade the student shall demonstrate:

- ability to position their own investigative work in relation to their specialization, and develop new and personal means of expression,
- in-depth ability to present and discuss their exploration materially, visually, verbally, in text
- ability to make assessments in reference to artistic, societal and ethical aspects
